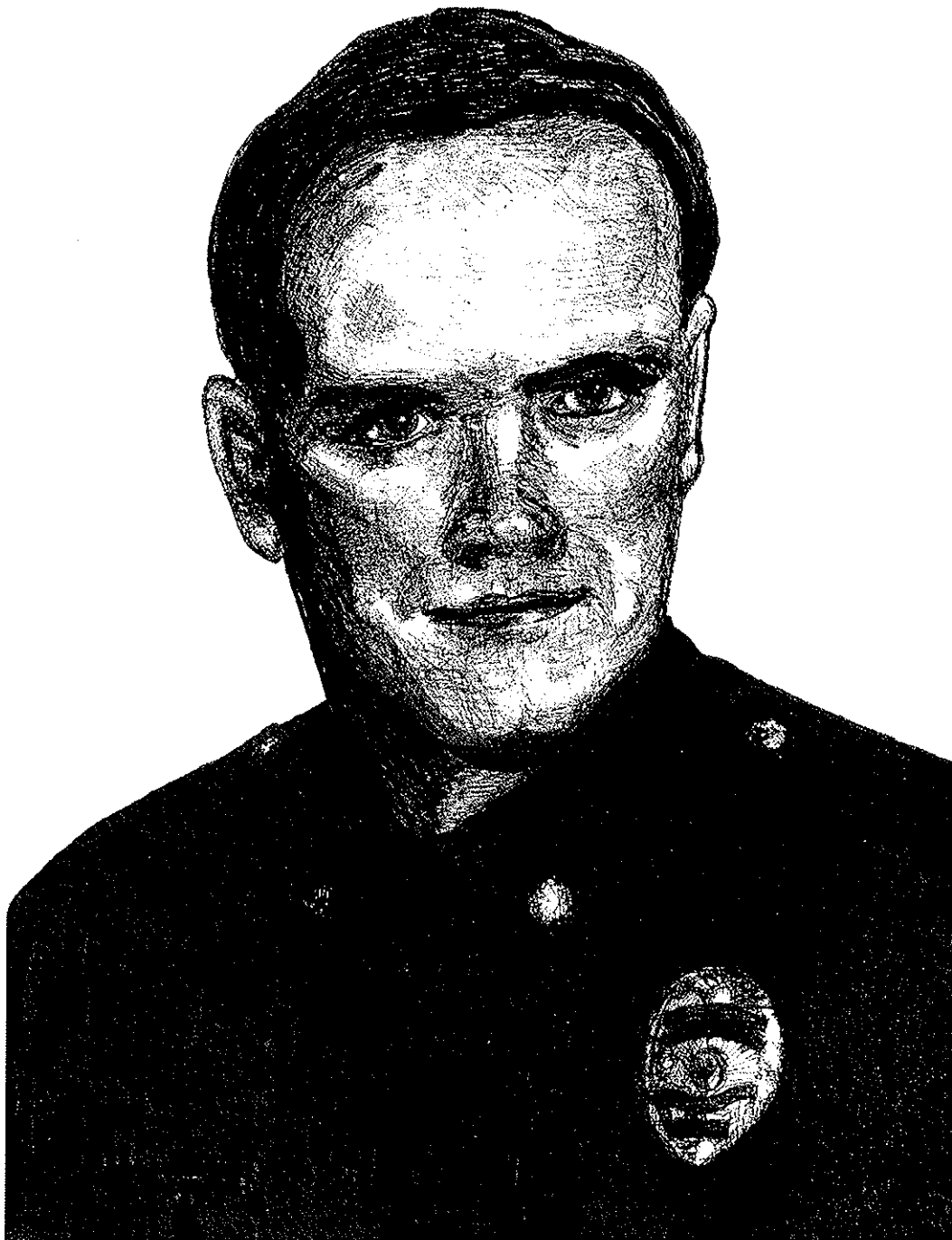

Alan Creech Memorial Scholarship

An annual award of \$500.00 will be awarded to the individual who, in facing adversity, best exemplifies the spirit, action and potential for a life of service that Alan exemplified. The scholarship committee will select the finalist based on the following attributes in order of relative importance.

- Written nomination
- Illustration of individual accomplishments
- Illustration of group accomplishments
- Financial need
- Scholarship

Finalists for the scholarship may be invited to a personal interview for final selection of the recipient. The nomination will include the Statement of Eligibility, Application Form and the Written Nomination. Nominations must be received between March 1st and April 15th. The scholarship will be awarded in June for the fall semester.

Statement of Eligibility

Any person meeting one or more of the following requirements is eligible for consideration for this scholarship to be used for an advanced degree or certificate program at an accredited college, university, trade or technical school.

Check each that applies.

- The nominee is a resident of the city of Nampa, Idaho.
- The nominee is a son, daughter or sibling of a member of a law enforcement employee in Ada, Canyon, Elmore, Owyhee, Payette or Washington counties in the state of Idaho.
- The nominee is a member of a United Church of Christ church within the Central Pacific Conference.

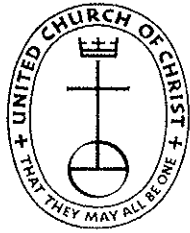

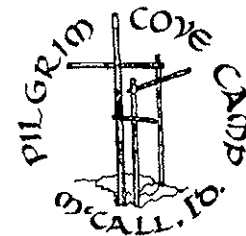
